In 2010 the stations continued an established internship program which offers local college students a chance to explore marketing and promotions opportunities within the radio broadcasting industry while earning college credits. The stations advertise and recruit participants throughout the year and generally host two to six interns per semester.

As part of our outreach effort Millennium Atlantic City has hosted elementary, secondary, home schooled groups of children, their teachers and parents, Girl and Boy Scout Troops and adult facilities for organized tours of our facilities. Through these tours the children learn about the different responsibilities of operating a commercial radio station by conversing with all those who are employed in programming, sales, promotions, engineering and administration.
